2.	<b>Name of Competition</b>	Setia City Mall Kpop Dance Battle 2020
3.	<b>Brief Description of Competition</b>	Setia City Mall Kpop Dance battle to search the hidden talents among the youth.
4.	<b>Brief mechanism of Competition</b>	<p>The nature competition comprises the following stages:</p> <ul style="list-style-type: none"> <li>• U18 Division : Level LG, Center Court Setia City Mall</li> <li>• Open Division : Level LG, Center Court Setia City Mall</li> </ul> <p>(a) The competition is open to Malaysian and all ages only.</p> <p>(b) Judges are <b>NOT</b> allowed to participate in the Competition.</p> <p>(c) Participating groups must consist of minimum two (2) members, Maximum thirty (13) members.</p> <p>(d) All participating groups are required to register and fill in all details required via Google Form .</p> <p>(e) Participating groups are required to submit a minimum three (3) minutes to a maximum five (5) minutes song routine when filling up online registration form by participants. Please bring along a thumb drive for backup use. Profanity and vulgarity of music lyrics are strictly prohibited.</p> <p>(f) The members in the online registration form submission <b>MUST BE THE EXACTLY SAME MEMBERS</b> for the division you take part. Strictly <b>NO CHANGES</b> and <b>REPLACEMENT MEMBERS</b> after submitting online registration. There will be marks deduction for lesser members.</p> <p>(g) <b>U18 Division</b> will be held in Setia City Mall on 28th of March 2020</p> <p>(h) <b>Open Division</b> will be held in Setia City Mall on 29th of March 2020</p> <p>(i) Maximum number of groups in both divisions is limited to Fifty (50) groups only and it is strictly based on first come first serve basis.</p> <p>(j) Contestants are encouraged to prepare one (1) sets of dance routines.</p>

		<p>(k) The group will be required to perform a minimum three (3) minutes to a maximum of five (5) minutes routine for both division.</p> <p>(l) The contestants must adhere to the mechanism of the Competition as may be briefed and communicated to the Contestants by the Organizer during the Competition Period.</p>
5	Nature of Competition	<p>(a) The Competition will be based on the ‘KPOP Dance Cover’ concept, thus the accepted song choices will be strictly based on Korean Pop Songs. The music must not contain inappropriate, lewd or offensive languages.</p> <p>(b) The Competition will be based on ‘KPOP Dance Cover’ concept, thus the original MV or Live Performances of selected KPOP Idol Groups will be taken as main guideline to judge the choreography of dance routine.</p> <p>(c) Participating groups are given the freedom to mix the song routine based on selection of songs from the <b>SAME KPOP Idol Groups</b>.</p> <p>(d) Usage of props is allowed with <b>PRIOR APPROVAL</b> from the Organizer.</p> <p>(e) All Participating groups are required to complete the whole competition in its entirety unless they have been disqualified.</p> <p>(f) Contestants are <b>NOT</b> allowed to join more than one (1) group.</p> <p>(g) No substitution or replacement of any members of the group is permitted at any time during the competition. In the case of any emergencies or unavoidable or unforeseen circumstances, the organizer in its sole and absolute discretion may allow a group to participate in the competition with less than the original number of members and marks deduction in the judging criteria.</p> <p>(h) The organiser reserves the right to change team members only if they are accidentally injured (with a medical certificate attached)</p> <p>(i) All participants must be free from any contractual obligation and/or any other legal encumbrance, which may prevent and/or restrict a group member and/or a group from</p> <p style="padding-left: 40px;">(i) participating and competing in the competition; and/or</p>

9	<b>Judging Criteria</b>	<p><b>CRITERIA:</b></p> <p>(a) KPOP Identity (20%) – originality of KPOP Idols' character, personalities and style limitation.</p> <p>(b) Dance Cover (30%) – dance moves according to Original MV and Live Performances of the selected KPOP Idols.</p> <p>(c) Precision &amp; Technique (30%) – solidity of dance skills and synchronization of dance steps of the entire dance crew and</p>

		<p>back up dancers.</p> <p>(d) Costume (10%) – effort &amp; thoughtfulness.</p> <p>(e) Creativity (10%) – contemplation in usage of suitable props to boost the identity of KPOP Artist and innovativeness &amp; smoothness in between song transition.</p>
